Background

This guide lists recovery housing facilities in the 20-county area served by Interact for Health in Greater Cincinnati. Information about the recovery houses was collected through a survey that was accessible between August 2019 and January 2020.

The survey link was emailed to known recovery house email addresses as well as shared by providers. If email addresses were not available, calls were made to recovery housing facilities to request participation.

Respondents were asked to provide information about their recovery house with the goal of building a comprehensive database on recovery housing services. Respondents were informed that a database was being developed to serve as a resource for providers so that they can make appropriate referrals to clients, and potentially as a resource for clients and their family members.

In order to provide a comprehensive list of all recovery houses in the area, the following guide includes not only the houses in which a representative completed the survey, but also includes houses that were confirmed to be recovery houses in the area. Missing information could be due to the house not completing the survey or not responding to specific question. If a house was not represented through survey data, information was collected through online research and information that was publicly available at the time this resource was being developed.

The information presented here represents details as of the end of the data collection period (ending January 2020).

Definitions

Recovery Housing:

According to Ohio Revised Code Section 340.01 (A) (3), "Recovery Housing" means housing for individuals recovering from drug addiction that provides an alcohol and drug-free living environment, peer support, assistance with obtaining drug addiction services, and other drug addiction recovery assistance. (ohiorecoveryhousing.org)

National Alliance for Recovery Residences Levels of Recovery:

Level I: Peer Run – Peer recovery support in a democratically run living environment.

Level II: Monitored – Peer recovery support and structure implemented by house rules with an emphasis on community and accountability.

Level III: Supervised – Peer recovery support plus extended-care programming with an emphasis on (re)habilitative life skill development.

Level IV: Service Provider - Peer recovery support plus life skills and clinical programming.

Medication Assisted Treatment:

MAT combines behavioral therapy and medications to treat substance use disorders. (<u>Substance Abuse</u> Mental Health Services Administration)
